Campground Rules

Camping Director: Pat Thieme (715) 965-3839

Fees: \$40 Camping fee for the week, helps with expenses of sanitation, garbage and nighttime security. Showers will be on the grounds Thursday (afternoon) through Sunday (morning), included in your camping fee.

Admittance fees are \$10 per day per person, weekend passes are \$25.00.

Payable at the admission gates/tent. Children 12 and under are free when accompanied by an adult.

Tractor and small engine exhibitors showing equipment will receive 1 weekend show pass when they register 6am - 9pm. If you attempt to park your camper before receiving your passes you may be asked to pay the admittance fees and must see campground personnel for a refund.

- Registration:**
1. Camper registration hours are 8 a.m. – 8 p.m. beginning on Sunday 8 a.m. to Friday 8 p.m. unless otherwise notified.
 2. Anyone camping before those hours will need to park in the parking lot and wait for registration to open the following morning.
 3. No early parking of campers without approval or assistance of camping personnel. Persons doing so may be asked to move or may be removed from the show grounds.
 4. Registered campers must have registration number visible in camper window or taped to the outside of the camper.
 5. Security personnel will be on duty at night and will be assisted by the Marathon County Sheriff Department if necessary.

Campground Rules:

1. No black or gray water may be discharged on grounds at any time. This is strictly prohibited. Sewer caps must remain on at all times while on premises.
2. **Quiet hours from 10:30 p.m. – 6:30 a.m.** No loud noises, music, barking dogs, campfires, or generators. **Warning:** If used incorrectly, portable generators can cause carbon monoxide poisoning, electric shock, fires and burns. Only run your generator in a well ventilated area and make sure the exhaust is placed in a well ventilated area and make sure the exhaust is placed far from other campers and tents.
3. **No motorized vehicles in campground during quiet hours.** This includes tractors, garden tractors, ATVs, gators etc. The only exception will be club operated shuttles.
4. Camp fires are permitted **FOR COOKING PURPOSES ONLY** and must be in above ground containers. Do not leave unattended or smoldering fires. Extinguish completely. **NO FIRES DURING QUIET HOURS.**
5. **Only service dogs are allowed on show grounds with paper proof.** Dogs must be **kept on a leash** in camping area. You **must** pick up all droppings and dispose of properly. Also, please control barking dogs.
6. No sales displays are allowed in the campground. If you have brought items for sale, you are required to set up in the flea market area and pay accordingly.
7. Only handicapped or disabled people will be allowed to camp in designated handicap camping area.
8. Parking extra vehicles is allowed only if they fit in your camp space. No parking is allowed in the driving lanes. Extra vehicles need to park in the general parking lot. No reserving a site for just parking vehicles.
9. Visitors to anyone in the campground should park in the general parking lot, pay the admittance fee, and ride shuttles to the campground.
10. Please pick up and dispose of all trash and garbage properly. Help keep all areas clean.
11. Anyone reserving extra sites must have permission from camper registration personnel.

Violators of any of the above rules risk being immediately and permanently removed from our show grounds, and may lose their club membership if applicable.
