Set-up Times: Wednesday, August 25 by noon (weather permitting)

Thursday, August 26 & Friday, August 27 starting at 7:30 am

Wednesday & Thursday: Use First Steam Hill Drive Entrance (Handicapped/Motorcycle Entrance) First Come Basis. Vendor parking available until 7 pm. Friday: Go to Exit Gate (Second Entrance on Steam Hill Drive) and you will be given direction from there.

- All Vendors must be on the Flea Market Grounds by 7 am to Park in the Flea Market on Friday, Saturday, and Sunday.
- Vendor Registration will be available until 5 pm on Wednesday and Thursday.
- WE DO NOT GUARANTEE OR RESERVE YOUR SPACES FROM LAST YEAR UNLESS YOU ARE A COMMERCIAL VENDOR.

Flea Vendor Rules & Regulations:

- NO SALES OF PREPARED FOODS, POP, WATER & OTHER DRINKS.
- NO SALES OF ITEMS WITH THE EDGAR STEAM & GAS SHOW LOGO.
- NO SALES OF PORNOGRAPHIC MATERIALS, LIVE ANIMALS OR FIREWORKS.
- NO SALE OF GUNS, KNIVES OR OTHER ITEMS THAT CONSTITUTE A WEAPON TO MINORS. MUST HAVE SAFTY DEVICE ON ALL FIREARMS. NO EXCEPTIONS.
- DO NOT SELL AMMUNITION OF THE CALIBER OF FIREARM YOU ARE SELLING.
- NO CAMPAIGN OR POLITICAL SIGNS MAY BE DISPLAYED ON THE GROUNDS.
- SIGNS THAT ARE OBJECTIONABLE TO SHOW PERSONNEL MUST BE REMOVED.
- PETS MUST BE LEASHED OR KENNELED AND STAY IN FLEA MARKET AREA.
- SALES TAX COLLECTION IS VENDORS RESPONSIBILITY.
- WHEN YOU LEAVE GROUNDS ALL TRASH MUST BE PICKED UP FROM YOUR AREA.
- CONTAINERS ARE LOCATED ON SOUTH END OF THE CAMPGROUNDS.
- All Vendors must have fire extinguishers in their space or spaces.
- All vendors must NOT use walkways for vehicle traffic from 7am-6pm on Friday, Saturday and Sunday.
- No driving on flea market grounds from 7am-6pm on Friday-Saturday-Sunday. If you must leave before 6pm, park in the General Parking for that day.
- Non-refundable ejection from grounds for any rule violation.
