## **CAMPGROUND REGISTRATION:**

- 1. Camper registration hours are 8am to 7:30pm beginning on Sunday, prior to show weekend.
  - a. Anyone arriving before those hours will need to park in the parking lot and wait for registration to open the following morning. Where else can you arrive early and park yourself? Public/Private campground arrival is generally in the afternoon... so be courteous and wait. No exceptions due to new State Rules!
  - b. No early/late parking of campers without approval or assistance of camping personnel. If you must park outside these hours, please call and make arrangements with camping staff; otherwise, you may have your camping unit towed at your expense.
  - c. All camping units must enter campground through the camper registration area. No traveling through flea market or private driveway to the campground.
  - d. Per WI ATCP 79.24 (2)... we are required to record the following information per registered campsite:
    - i Primary Contact Information
    - ii Arrival and Departure Dates
    - iii Number of campers in person's party
  - e. Per WI ATCP 79.11 (5)(a)... each campsite is limited to 6 campers or an individual family.
  - f. Those wanting to camp in a group... PLEASE have each person in your group reserve themselves so that we get correct information the first time around. Just let them know your group name when they reserve. Reserving is not the same as registering... reserving only holds a site for you, it's not yours until you are registered in by camping personnel (same as any other campground in the state).
- Registered campers must have registration card visible in camper/vehicle/tent window or taped to the
  outside of the camper at all times near main entrance of unit. All registered vehicles (includes ATV/UTV/Golf
  Carts/etc) must have tag displayed at all times while on show grounds, including campground. No sharing of
  vehicle tags allowed.
- 3. Security personnel will be on duty at night and will be assisted by the Marathon County Sheriff Department, if necessary.
- 4. Fees:
  - a. Show Admittance fees, separate from camping fees & personal vehicles fees, are payable at the admission gates/tent.
  - b. Children 12 and under are free when accompanied by an adult.
  - c. Camping fees See website for current rate per site. Free-will donations are accepted and greatly appreciated.
  - d. ATV/UTV/Golf Cart fees See website for current rate per vehicle, for more information and where to register them.
    - i Campground registration of vehicle use is separate from show ground registration of vehicle use. We are working to combine these for the near future. Until then, you must register for each area of use!

## **CAMPGROUND RULES:**

- 1. All camping units, including tents, must be 10 feet apart in all directions. WI ATCP 79.13.
- 2. No black or gray water may be discharged on the grounds at any time. Sewer cap **must** be on <u>before</u> arriving and be on at <u>all</u> times while here. It is strictly prohibited to discharge on the grounds. WI ATCP 79.15
- 3. **QUIET HOURS** are from 10:30pm to 6:30am. No loud noises, music, barking dogs, or generators (unless with Medical Card issued by Camping). **WARNING:** If used incorrectly, portable generators can cause carbon monoxide poisoning, electric shock, fires and burns. Only run your generator in a well ventilated area and make sure the exhaust is placed far from other campers and tents. Absolutely no fireworks allowed on showgrounds (this includes campground).
- 4. **No motorized vehicles in campground during quiet hours.** This includes tractors, garden tractors, ATVs, Gators, golf carts, etc. The only exception will be club operated shuttles. All operators <u>must</u> be of legal driving age and with a valid driver license. No youthful drivers unless approved by a Show Director!

- 5. Campfires are permitted **FOR COOKING PURPOSES ONLY** and **must** be in above ground containers. Do not leave unattended or smoldering fires. Extinguish completely. No fires during quiet hours. Per WI ATCP 79.22 (3)(a)... all campfires need to be a minimum of 5 feet away from all camping units, structures and motor vehicles. The above ground rule is the club's choice and will be enforced!
- 6. Only "service" dogs are allowed on show grounds. Therapy animals are **not** allowed on show grounds. Dogs must be **kept on a leash** in camping area. You **must** pick up all droppings and dispose of properly, no burying of animal feces. Also, please control barking dogs.
- 7. No sales displays allowed in the campground. If you have brought items for sale, you are required to set up in the flea market and pay accordingly. Any signs found will be removed by Show Personnel.
- 8. \*\*\* No displaying of any show registered items (tractors, lawn tractors, etc) on campground unless using for official business. All items must be on display on the show grounds, including overnight. You are getting a free admission for having it on display, so display where it belongs! \*\*\*
- 9. Only handicapped or disabled people will be allowed to camp in designated handicap camping area. Handicapped spots are limited and **not** being allowed for those assisting the handicapped camper unless in same site camping. We will try to park the assisting camper in a nearby site.
- 10. Each campsite is allowed up to 2 motorized vehicles within your camp space. All other extra vehicles must park in the general parking lot. No parking is allowed in the driving lanes or at the end of camping rows. Vehicle tags must be displayed on registered vehicles... no sharing of tags! This is for emergency access reasons determined by our local fire department.
- 11. Visitors, to anyone in the campground, must park in the general parking lot, pay the admittance fee, and ride the shuttles to the campground. We cannot have excess vehicles in campground due to state/county/local laws, so please have your visitors park in general parking.
- 12. Please pick up and dispose of all trash and garbage properly. Help keep all areas clean. Unclean sites, after leaving, may have your privilege for future camping at our show revoked.
- 13. Anyone reserving extra sites must have permission from camper registration personnel. Site(s) must be used for camping, not vehicle parking. We are limited with space due to updated State rules!
- 14. Tent sites must be occupied for sleeping on a daily basis. If site is being used to park extra vehicles without sleeping occupants, site will be taken away and re-issued to another camper as needed along with future privileges being revoked.

Violators of any of the above rules risk being immediately and permanently removed from our show grounds, lose all fees paid, and may lose their club membership, if applicable.
